**Policy Pursuant to HB 1379
Purchase of Firearm by Honorably Retired
Law Enforcement Officers**

The following policy is hereby established and implemented pursuant to HB 1379 pertaining to Government Code Section 1 Chapter 170 Section 170.002 Purchase of Firearm by Honorably retired law enforcement officers.

Honorable retired law enforcement officers may purchase a firearm from the County under the following provisions:


1. This policy only applies to Honorably retired law enforcement officers with a minimum of eight (8) years employment with Kaufman County.
2. The Honorably retired law enforcement officer will be allowed to purchase his/her issued hand gun only. (No seized or forfeited weapons to be sold)
3. The Fair Market Value of the firearm will be determined by the purchasing agent using the Shooter's Bible price. Or in the alternative, by using the average of three sale price totals of like firearms on gunbroker.com.
4. The purchase price of the firearm by the Honorable retired law enforcement officer will be set at 50% of the Fair Market Value as determined in #3 above.

This policy is hereby established and implemented this 31st Day of December, 2012.
