

As you know Robert Martin has requested service of 36 lots on CR 4116 as shown on the attached vicinity maps. As you see from Plate 2 there is an 8-inch line on the south side of CR 4116 that fronts the proposed lots. When the lots are developed the meters can be set as needed. The additional connections added to the hydraulic model caused a reduction of roughly 2 psi to the calculated residual pressure. Prior to development the calculated residual pressure in this area was roughly 51 psi. Therefore, the additional demand did not reduce the calculated residual below the TCEQ minimum criteria, and no off-site improvements are recommended.

I have also attached a summary of the facility capacities shown on Figure 1. As you see there is adequate capacity for the requested services.

I recommend that Mr. Martin 's request for service be granted. If Mr. Martin has not proceeded within 6 weeks I recommend that the approval be voided, and Mr. Martin be required to re-request the service.

#### **DEED RESTRICTIONS**

#### FOR

#### **GASTONIA ESTATES**

This is a Declaration made this 1<sup>st</sup> day of November 2018, by Kaufman County Land Trust, hereinafter called Grantor.

#### WITNESSETH:

WHEREAS, Grantor is the owner of all that certain real property located in Kaufman County, Texas described as:

GASTONIA ESTATES, as per PLAT

WHEREAS, Grantor desires to create a quality developments with restrictions, covenants, impositions, easements, charges and liens, as hereinafter set forth for the preservation of the property values for the owners therein.

NOW, THEREFORE, it is hereby declared that all of the property described above shall beheld, sold and conveyed subject to the following assessments, and all casements and other matters of record, restrictions, covenants, and conditions, which are for the purpose of protecting the values and desirability of, and which shall run with, the real property and shall be binding on all parties having any right, title or interest in or to the above described property or any part thereof, and their heirs, successors and assigns, and which easements, restrictions, covenants and conditions shall inure to the benefit of each Owner thereof.

#### **ARTICLE 1-DEFINITIONS**

The following words when used in this Declaration shall have the following meaning:

- 1. "Grantor" shall mean and refer to Kaufman County Land Trust, its successors and / or assigns or any or all of its rights under this Declaration.
- "Property" shall mean and refer to that certain real property herein described and such additions thereto as many hereinafter be brought within the jurisdiction to the association.

#### **DEED RESTRICTION FOR Gastonia Estates - page 1**

- "Association" shall mean and refer to any homeowners association or not-for-profit corporation formed by 72% of the Owners of the property, based on a percentage of the lots owned, to administer and enforce these restrictions.
- 4. "Owner" shall mean and refer to the record owner, whether one or more persons or entities, of the fee simple title to any lot or portion of a lot, their heirs, successors, legal representatives or assigns, but excluding any person or entity having an interest in a Lot merely as security for the performance of any obligation.
- 5. "Committee" shall mean representatives of Grantor, or his assigns, or appointees as appointed by the Grantor.
- 6. "Lot" shall refer to that portion of any of the lots of land shown on Exhibit "A" located in Kaufman County, Texas on which there is or will be set/built a single-family dwelling.
- 7. "Junk Cars" shall mean any vehicle not moved within 60 days of notice to move same and not having a current inspection sticker and/or current license plate.

#### **ARTICLE II- GENERAL RESTRICTIONS**

- Use and Restrictions. The Property shall be used only for single family residence purpose.
   Individuals may practice occupations in their homes provided that such occupation is conducted solely within the residential dwelling or Grantor approved shop and only if such activity does not interfere with the enjoyment or use of the other owner's rights. No other commercial activity will be permitted.
  - A) All dwelling shall be in accordance with the building lines established on the property survey as filled plat for Gastonia Estates subject to such exceptions as may be a request for a variance shall be presented to the Grantor or the Association. No building construction shall be allowed until a building permit is issued by the Kaufman County Development Services Office. Each home shall be built on site with new material with exterior to be finished within 120 days from beginning of construction.
  - B) Minimum Floor Area. The total air-conditioned/heated living area (floor area) of the main residential structure, as measured to the outside of the exterior walls but exclusive of open porches, garages, patios and detached accessory buildings, shall be not less than 1,600 square feet on single story and 1,850 square feet on two stories.
  - C) No truck, bus or trailer shall be kept parked in the street in front of any property except for construction and repair equipment while a residence of residences are being repaired in the immediate vicinity.
  - D) No Junk Cars shall be permitted on the property.

- E) Dogs, cats and other domestic household pets may be kept and maintained by any Property Owner as long as they are properly leashed or corralled not to exceed six per household. No fighting games hens and roasters will be allowed. Livestock shall not exceed one adult head, per acre of property owned. No animals shall be maintained in any manner that interferes with the use and enjoyment of other Property Owners.
- F) No garage, outbuilding, shock, barn, tent, camper, motor home, travel trailer, or temporary structure shall be occupied as a dwelling on a temporary or permanent basis. Only homes with foundation shall be allowed.
- G) No billboard or advertising larger than 16 square feet shall be placed or maintained provided however, that the Grantor in its subdividing and sales may place or erect and maintain customary signs for it or its accredited agents. Billboard or advertising shall be in accordance with the laws of the State of Texas and applicable local regulations, ordinances and laws.
- H) No noxious or offensive trade or activity shall be carried on in the Property, nor shall anything be done therein which may be or become a nuisance to the neighborhood. No property shall be used as a dumping ground for rubbish. No trash shall be burned without permit.
- Septic System place on each property must be approved and licensed by the Environmental Health Division of the Kaufman County Health Department.

#### 2. Building Materials; Exterior Items and Surfaces

A. The total exterior wall area, except windows and doors, of each single-family residence building constructed or placed on a tract shall be not less than seventy percent (70%) brick, brick veneer, stone, stone veneer or other material approved by the Grantor which may include approval of Victorian-stylehomes. In calculating the area required to be constructed of the foregoing materials, the area covered by the following shall be excluded from such calculation; gables or other areas above the height of the top of standard height first-floor windows. All roofs shall have a minimum pitch of 6/12.

- B) Outbuilding may be constructed of metal or other Grantor approved material.
- 3. <u>Plans, Permits, Specifications and Locations of Buildings.</u> The plans, specifications and location of all the construction thereunder, and every alteration of any building or structure shall be in accordance with building, plumbing and electrical requirements of all regulatory codes. Furthermore, it shall be the obligation of each Property Owner to comply with the building codes and purchase the required permit for construction or placement of homes that are within the city limits of a regulating body or city. Neither the Grantor nor the Association will assume the responsibility in this regard before, during or after construction.

- 4) Fences. No sheet metal fence or snow fence or similar type of fences shall be erected.
- 5) <u>Maintenance of premises</u>. In order to maintain the standards of the property, no refuse or unsightly objects shall be allowed to be placed or suffered to remain anywhere therein. The property, building improvement, landscaping and appurtenances shall be kept in good, safe, clean and neat condition. No wrecking yards are allowed.
- 6) <u>Notice to Owners.</u> Notice to any Owner of the violations of any of these restrictions or any other notice therein requested shall be in writing and shall be delivered or mailed to the Owner at the address shown on the tax rolls of Kaufman County, Texas.
- 7) <u>Utility Easements.</u> All utility, drainage and road easements as shown on the properties are reserved for the uses indicated. No shrubbery, fence, building, structure or other obstructions shall be placed in any easement or alleyway. Right of use for ingress and aggress shall be had at all times over any dedicated easement, and for the installation, operation, maintenance, repair, or re moval of any utility, together with the right to remove any obstruction that may be placed in such easement which would constitute interference with the use, maintenance, operation, or installation of such utility. Neither Grantor nor the Association shall be liable for any damage done by his or their assigns, agents, employees, or servants, to shrubbery, trees or flowers to other property of the Owner situated within any such easement.
- 8) Non-liability of Grantor, Association or Committee. The Grantor, Association nor the Committee shall not in any way or manner be held liable or responsible for any violation of these restrictions by any person other than itself. In the event the Grantor or Association shall deem it necessary to enforce these restrictions against any Owner, said Owner shall be required to pay reasonable attorney's fee and court costs, if the Grantor or Association shall prevail in said litigation.
- 9) Declaration or Restrictions Run with the Land. These herein contained restrictions shall constitute an easement and imposition in and upon the Property and every part thereof, and they shall run with the land and shall inure to the benefit of and be binding upon and enforceable by Grantor or Association or Owner for a period of ten (10) years from the date of recording these Restrictions.
- 10) Owner Compliance. The covenants, restrictions, and servitudes imposed by the Declaration of Restrictions shall apply not only to Owners, but also to any person, or persons, entity or entities, occupying the property by permission or invitation of the Owner or his tenants, expressed or implied. Failure of the Owner to notify said persons or occupants of the existence of said restrictions shall not in any act limit or divest the right of Grantor, Association, or other Owners of the enforcement of these restrictions, and in addition, the violating Owner shall be responsible for all violations of these restrictions by his tenants, licenses, invitees or guests, licensees or invitees or his tenants at any time.

- 11. <u>Enforcement.</u> Enforcement of these covenants and restrictions shall be by any procedure at law or in equity against any person or persons in violation of or attempting to violate any covenant or restriction. In additional to legal action for damages, enforcement of these covenants and restrictions shall include the right to sue for and obtain an injunction to prevent any breach or threatened breach of these restrictions or to otherwise enforce compliance with the covenants and restrictions. No failure or delay in enforcement shall constitute a waiver of any violation. Any costs of collection, including reasonable attorney's fees incurred in the enforcement of these covenants, restrictions, or liens shall be paid by the violating Owner.
- 12. <u>Severability Clause</u>. Invalidation of any of these restrictions in whole or in part, by a court of competent jurisdiction shall not affect any of the other restrictions. And all other provisions shall remain in full force effect.
- 13. <u>Part of Contract or Deed</u>. The provisions hereofare hereby made a part of each contract or deed for a part of all the Property, and each such contract or deed shall be executed, delivered and accepted upon and subject to the provisions and conditions set forth therein.

#### **ARTICLE III-MISCELLANEOUS PROVISIONS**

- <u>Duration</u>. The covenants, conditions and restrictions of this Declaration shall be effective for a term of ten (10) years from the date this Declaration is recorded, after which time said covenants, conditions and restrictions shall be automatically extended for successive periods of ten (10) years.
- 2. Amendments. Any article of this Declaration may be amended in the following manner
  - A. Until one hundred percent (100%) of the Lots are sold by the Grantor to persons or legal entities not affiliated with or controlled by Grantor, Grantor shall have the exclusive power and right to amend the restrictive covenants upon this property and such right and power must be exercised in writing, and shall become effective when an instrument is filed in the Deed Records of Kaufman County, Texas with the signature of the Grantor.
  - B. During the existence of this Declaration, as from time to time supplemented or amended, the Grantor shall have the exclusive power and right to allow deviations from the present form of or the specific and general intentions and purposes of the restrictions and covenants set forth herein.
  - C. Grantor may appoint a Committee before hundred percent (100%) of Lots are sold which shall have the right and power to amend the restrictive covenants upon this property with consent of at least sixty percent (60%) of the Owners. Such right and power must be exercised in writing, and shall become effective when an instrument is

filed in the Deed Records of Kaufman County, Texas with the signature (s) of the Committee.

- D. After one hundred percent (100%) of the Lots are sold by Grantor to persons or legal entities not affiliated with or controlled by Grantor, those persons or legal entities who own Lot (s) shall, with consent by not less than seventy percent (70%) of the Lot Owners have exclusive power and right to amend any article hereof.
- 3. <u>Waivers and Approvals.</u> Waivers and approvals may be solely granted by Grantor or Committee until the date set forth in paragraph 2.A above. Any grant of waiver or approval pursuant to paragraph 2.A above will not guarantee a waiver or approval of any subsequent request, whether of the same nature or otherwise.



#### MEMORANDUM OF UNDERSTANDING

The purpose of this Memorandum of Understanding is to ensure that the goals and responsibilities of the regional Area Information Center (AIC) and Community Information Centers (CICs) have been reviewed and mutually agreed upon. Further, this agreement provides that both agencies agree to cooperate and mutually support each other to the extent necessary to ensure that all citizens across the North Central Texas Dallas Region have access to comprehensive information and referral resources.

**Prohibition of Discrimination:** Discrimination on the basis of race, color, creed, sex, and handicap will not be permitted. The AIC and the CIC will actively comply with provisions of Title VI of the Civil Rights Act of 1964 and the Rehabilitation Act of 1973, which prohibits discrimination against persons in all programs, services and activities.

The mission of the Area Information Center is: to serve as the area coordinator of a comprehensive health and human service information and referral network for the North Central Texas Region (Collin, Denton, Dallas, Ellis, Hunt, Kaufman, Navarro, and Rockwall Counties).

As an Area Information Center (AIC), the Community Council of Greater Dallas, 2-1-1 Texas InfoLine agrees to:

 Create greater awareness of available information and referral services, throughout the North Central Texas-Dallas Region. Coordination and consolidation of services throughout the region will avoid any duplication of services and funding, as well as provide a focused and inclusive public awareness and marketing strategy for information and referral.

- Work collaboratively with community partners to maintain Community Information Centers within the North Central Texas-Dallas Region in order to provide seamless access to comprehensive information and referral services locally, by telephone or in person when necessary.
- Maintain and update the regional database of health and human service resources for the North Central Texas-Dallas Region, thus eliminating the need for multiple databases containing the same information.
- Establish a centralized Information and Referral 2-1-1 that will provide quick, single access to health and human services available in our region.
- Provide information and referral services by telephone, email, internet, and TDD at 2-1-1 Texas InfoLine.
- Provide information and referral about state and national training opportunities to CICs.
- Participate in all activities pertaining to the North Central Texas-Dallas Region's involvement in 2-1-1 Texas.
- Provide service documentation monthly stating the total number of calls received, the service need, and any unmet needs from the given CIC.

#### As a Community Information Center (CIC), we agree to:

- Work closely with the AIC to promote greater awareness of available information and referral services, throughout the North Central Texas- Dallas Region.
- Provide local support for the operation and maintenance of the Area Information Center, the area coordinator of the regional information and referral network.
- Serve as the first point of contact in the community for locating health and human services for inquires through telephone or walk-in assistance. CIC professionals work with community members and professionals to determine the root cause of an individual's problem and refer him/her to an appropriate service provider.

- Designate a contact person within the CIC to act as a liaison between the AIC and the CIC.
- Provide updates and/or notification of changes in local agency information to the AIC as soon as possible in order to keep regional information up-to-date in the 2-1-1 Texas
   InfoLine database. This will be accomplished by electronic transfer, email, or fax.
- Provide awareness of information and referral training opportunities to 2-1-1 Texas
   InfoLine center staff to promote professionalism in the field.

The following applies to agencies that are utilizing a computer database system: The CIC must be able to build and maintain a computerized database that complies with the standards set by the Texas Information and Referral Network (TIRN).

#### Entries in the database will:

- Include the TIRN established data elements.
- Follow the TIRN Style Manual and meet the TIRN Inclusion Criteria.
- Data maintenance will adhere to data maintenance standards as outlined by AIRS (Alliance of Information and Referral Services).

This is a true partnership between the Community Council of Greater Dallas Area Information Center and the Community Information Center, with the goal of providing greater awareness of and accessibility to available information and referral resources and services through 2-1-1 Texas.
