

- 3. **Consider and possible action** concerning an order by the Commissioners Court of Kaufman County, Texas canvassing the returns and declaring the results of a Bond Elections held November 5, 2019, and containing provisions necessary and incidental thereto.

(a) in the open meeting covered by the notice upon the reconvening of the public meetings; or

(b) at a subsequent open public meeting of the Commissioners' Court upon notice thereof; as the Commissioners' Court shall determine.
