**MOTION TO ADJOURN**


There came on to be considered a motion to adjourn regular meeting.

A motion was made by Commissioner Jerry Rowden and seconded by Commissioner Ken Leonard.


Whereupon said motion was put to a vote and motion carried.



COMMISSIONER PCT. 2




KENNETH SCHOEN
