INVOCATION;


PLEDGE OF ALLEGIANCE TO THE AMERICAN FLAG;

15. Adjourn Regular Meeting.

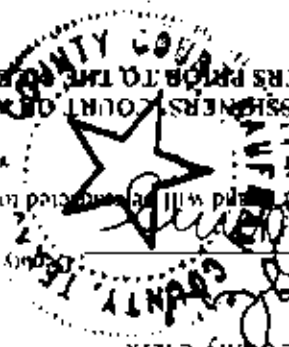
